Sealed bid proposals, plainly marked with the "Paving Bids" on the outside of the envelope, addressed to the Town Administrator, **should be mailed to 12 Gearty Way, Campton, NH 03223, on or before May 1, 2023.** The bids will be publicly opened and read aloud at the regularly scheduled Board of Selectmen's meeting at 5:30 pm that evening.

The Town reserves the right to reject any or all bids, to waive technical or legal deficiencies, and to accept any bid that the Town may deem to be in the best interest of the Town. The Town reserves the right to terminate the contract if the quality of the material varies significantly.

Project Scope

The Town of Campton seeks qualified contractors for road paving during the summer of 2023 and 2024. The Town seeks proposals from qualified contractors to provide all the necessary materials, labor and equipment to complete the project.

Summer of 2023

Puckerbrush Road (Section from; Approximately 5,176 feet)

- Reclaiming the Asphalt (3,500' starting from Ellsworth Hill Rd ending at Libby Lane)
- Supply & Install Asphalt Base 2.5"
- Supply & Install Shim ½"
- Supply & Install Wearing Course 1.5"
- Supply Flaggers
- Supply & Install Gavel Shoulders 2 feet wide

Summer of 2024

Town Pound Road (Section from; Approximately 3,343 feet)

- Reclaiming the Asphalt (2,178' Starting from new pavement on the North entrance)
- Supply & Install Asphalt Base 2.5"
- Supply & Install Shim ½"
- Supply & Install Wearing Course 1.5"
- Supply Flaggers
- Supply & Install Gavel Shoulders 2 feet wide

The Town of Campton requests that billing be done with one bill if possible. Any additional work that may be added to the project should be billed separately from the original quote.

Required Timeline

All work must be completed by September 30 of the stated project year.

Submit sealed proposals to: Town of Campton, Office of the Select Board, 12 Gearty Way, Campton NH 03223 **no later than 3:30 pm on May 1, 2023**. Proposals received after this date and time will not be considered. Please mark the envelope " Annual Paving RFP"

All bids will be presented at a public meeting of the Select Board, **May 1st, 2023, 4:30 PM**.

Proposals Requirements

Proposals should include the following:

- Fixed-price quote for materials, labor, and work schedule, including total quantity of road surface to be paved and total quantity of material to be appropriated.
- A list of references of equivalent work included with bid.
- Pre-qualification by the NH Department of Transportation in the category of paving.
- A copy of applicable insurance certificates to include proof of general liability coverage and Worker's Compensation Coverage in compliance with State of NH guidelines.

Municipal Escape Clause

If the Town of Campton, as a municipal corporation and governmental entity, fails to appropriate or authorize the payment (by and through its legislative body) of any amounts due and owing under the terms of this Agreement, such an event will be deemed a default. However, the sole remedy for this type of default will be to declare this Agreement terminated. The chosen bidder will not be eligible for any monetary damages in the event of a non-appropriation by the Town of Campton's legislative body. As a result, the Town of Campton's governing body shall be required, by the terms of this Agreement, to include as well as recommend any and all sums owed from this Agreement as part of any annual budgetary process prior to the submission of this cost item before the Town of Campton's legislative body.
